- 1. B) For Installation, Commissioning and Testing (ICT): 100% payment will be released within ten (10) days o f issue of consignee receipt-cum-acceptance certificate (CRAC).

B. Disputes and Arbitration Clause:

a. Arbitration in case of Domestic vendor

In case of any dispute, difference, or question which may at any time arise between the parties hereto or a ny person claiming under them, touching or arising out of or in respect of this agreement or the subject m atter thereof shall be referred to the arbitration. Both the parties shall appoint the sole arbitrator with mut ual agreement in line with the Arbitration and Conciliation Act, 1996. The provisions of the Arbitration and Conciliation Act, 1996 and as amended from time to time shall apply to the proceedings conducted under t he arbitration. In case the party (parties) fail to appoint the sole arbitrator within 30 days from the date of r equest, the requesting party may approach the Court of Competent jurisdiction to appoint an Arbitrator. T he decision of such arbitrator shall be final and binding on the parties. The venue of Arbitration shall be at Mumbai. The language of the Arbitration shall be English.
