i) The bidders shall submit copies of work-orders, issued by their clients, for me chanical maintenance jobs in Chemical/Fertilizer/Power Plant/Petrochemical ind ustries/Heavy Water Plant operation in India during the last seven years ending the last day of month previous to the one in which this subject tender is floated/ issued should be fulfilling, either of the following:

### Minimum value of work must be as follows:

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
