If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

1. Bidders must upload MSME Certificate in MSME Column & other certificate at their relevant column in G eM portal.

2. Bidder must provide service for ANNUAL OPERATION & MAINTENANCE CONTRACT FOR SEWAGE TREATM ENT PLANT OF RHE & OE AT AFK WITH SEWAGE PUMP HOUSES LOCATED NEAR D TYPE, A TYPE QTRS, PAR K ROAD & MHASOBA GATE. AS PER SPECIFICATION NO. AFK/EST(M)/NEW/AMC/STP RHE & OE/01/2024 DT. 23/08/2024.

3. Bidder must submit stamped and signed AFK SCOPE OF WORK i.e. Specification No. AFK/EST(M)/NEW/A MC/STP-RHE & OE/01/2024 Dtd. 23/08/2024 and submit the same along with Bid documents.

4. Bidder must have Experience of similar services i.e. Annual Operation & Maintenance contract for Sewa ge Treatment Plant with Sewage Pump Houses in last 05 years. 6. Consumables like grease, lubricating oil etc. tools, tackles & equipment for maintenance and operation t o be arranged by contractor. Parts / spares (both electrical and mechanical) costing more than Rs. 2000/-which are required for replacement due to wearing/ ageing will be provided by factory.
