1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 4. 5. 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 2. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

3. Generic

5. Certificates

6. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates

1. Compliance Statement: The firms must submit compliance statement -cum-technical bid in the format gi ven in "Technical bid" (excel format to be uploaded) failing which their offer will be treated as incomplete and may be rejected.

2. Guarantee/ Warranty: Warranty of the quoted equipment should be minimum 24 months. Comprehensiv e onsite warranty is required after warranty wherever asked.Warranty Terms period will start from the dat e of installation of items. GENERAL TERMS AND CONDITIONS FOR BIDDERS

1. The tenderer is being permitted to give tenders in consideration of the stipulations on his part that after submitting his tenders, he will not resale from his offer or modify the terms a nd conditions thereof. If the tenderer fails to observe and comply with the foregoing stipulat ion, the aforesaid amount of EMD will be forfeited by the Institute. In the event of the offer

made by the tenderer not being accepted, the amount of earnest money deposited by the t enderer will be refunded to him after he has applied for the same, in the manner prescribe d by the Institute.

2.All technical details should mandatory be provided in the bid. Rates provided in the Price Bid (BOQ) should be all inclusive i.e. packaging & forwarding, insurance, etc. and FOR ICAR -CIRG, Makhdoom. No payment over & above the quoted rates shall be made under any cir cumstances Taxes in force are payable as per norms.

3.The Director, ICAR-CIRG, Makhdoom, reserves the right to reduce or terminate the period of contract or t o extend its duration in the interest of the Institute, for any justifiable reasons, not mandatory to be comm unicated to the tenderer.

4.Decision of the Director, ICAR-CIRG, Makhdoom, shall be final for any aspect of the contract and binding to all parties. Disputes arising, if any, on the contract will be set tled at his/her level by mutual consultation and in case of failure of settlement, disput e shall be referred to the sole arbitrator to be appointed by the Director, ICAR-CIRG, and Makhdoom. The decision of the sole arbitrator so appointed shall be final and bin ding on the parties. Arbitration proceedings shall be governed by the Arbitration & Co nciliation Act, 1996.

5.The supply/ service should be made within the time frame mentioned in the Supply/ Work order. In case of any extension, prior approval of the office shall have to be taken. In case, the supply/ work is not compl eted within the time limit, the supply/ work order shall stand cancelled and the bid security would stand for feited.

6. There should be no legal suit/criminal case pending or contemplated against the Company on grounds o f moral turpitude or for violations of any of the laws in-force. Also, the firms should not have been Black Lis ted by any Govt. Department. The Tenderer must enclose this declaration at the time of submission of bid.

7. Payment shall be made only on actual delivery in good condition. No advance or part payment request shall be made/ considered under any circumstances. Institute is not responsible for payment of transit insu rance charges. Unordered supply shall not be entertained.

8. Legal jurisdiction for all disputes shall be within the purview of the Mathura Court.

9. Risk Clause: The Institute reserves the right to cancell the order at any time, if the services are found un satisfactory by giving a show-cause to be replied within a week and also has the right to award the order t o any other agency at the risk and cost of current agency and excess expenditure incurred on account of t his can be recovered from S. D. or pending bills or by rising a separate claim.

10. Liquidated Damages Clause: Except as otherwise as mentioned above, if the supplier fails to deliver a ny or all of the goods or perform the services within the time period (s) specified in the contract, the Institu te shall, without prejudice to its other remedies under the contract, deduct from the contract price, as liqui dated damages, a sum equivalent to 0.5% (half percent) of the delivered price of the delayed goods or un performed services for each week of delay or part thereof until actual delivery or performance, up to a ma ximum deduction of 10% (ten per cent) of the delayed goods' or services' contract price. Once the maxim um is reached, the purchaser may consider termination of the contract, if the same have not been terminat ed already. Further, during the above mentioned delayed period of supply and/or performance, the supplie r, notwithstanding any stipulation in the contract for increase in price for any ground, shall not be entitled to any increase in price and cost, whatsoever, which take place during the period of delay. But, neverthele ss, the purchaser shall be entitled to the benefit decrease in price & cost on any ground during that period of delay.

11. Force Majeure: Except as otherwise as mentioned above, the supplier shall not be liable for forfeiture o f its performance security, liquidated damages or termination for default, if and to the extent that its delay in performance or other failure to perform its obligations under the contract is the result of an event of For ce Measure. For purposes of this clause, "Force Measure" means an event beyond the control of the suppli er and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but a re not restricted to, acts of the purchaser in its sovereign capacity wars or revolutions, fires, floods, epide mics, quarantine restrictions and freight embargoes. If a Force Measure situation arises, the supplier shall promptly notify the purchaser in writing of such conditions and the cause thereof. Unless otherwise directe d by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as fa r as reasonably practical & shall seek all reasonable alternative means for performance not prevented by F orce Measure event.

12. Termination for insolvency: If the supplier becomes bankrupt or otherwise insolvent, the purchaser ma y terminate the contract by giving written notice to the supplier, without any compensation to the supplier , provided, that such termination will not prejudice or affect any right of action or remedy which has accru ed and/or will accrue thereafter to the purchaser.

13. 16. Turnover

OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. In case of bunch bids, the OEM of CATEGORY RELATED TO primary product having highest bid value should meet this criterion.

17. Warranty

Over and above the normal Warranty terms as per GeM GTC, the successful bidder / OEM shall have to provide Comprehensive Warranty during the entire Standard warranty period as per contract. : The comprehensive warranty shall be covering the following scope

Comprehensive onsite warranty is required after warranty wherever asked. Warranty Terms period will sta rt from the date of installation of items. The Bidder representative shall be allowed entry upon consignee premises for such visits, only upon the express conditions that the Bidder will release and indemnify the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expenses incurred as a result of such visit.

3. The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding, working conditions, weather etc. on its own before submission of the bid.

19. Past Project Experience

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. 21. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

22. Warranty

Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.

23. Generic

24. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

25. Warranty

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 7 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG).Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imberse the cost of such service / rectification to the Buyer.

26. Past Project Experience

The Bidder / OEM {themselves or through reseller(s)}, should have executed project for supply and installation / commissioning of same or similar Category Products during preceding 3 financial years (i.e. current year and three previous financial years) as on opening of bid, as per following criteria:

(i) Single order of at least 35% of estimated bid value; or

(ii) Two orders of at least 20% each of estimated bid value; or

(iii) Three orders of at least 15% each of estimated bid value.

Satisfactory Performance certificate issued by respective Buyer Organization for the above Orders should be uploaded with bid. In case of bunch bids, the Category related to primary product having highest bid value should meet this criterion

27. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

28. Generic

The successful bidder has to supply all essential accessories required for the successful installation and commissioning of the goods supplied. Besides standard accessories as per normal industry practice, following accessories must be part of supply and cost should be included in bid price:

29. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

30. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

i) The Seller fails to comply with any material term of the Contract.

ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

Disclaimer/अस्वीकरण
