- 1. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. # 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1). Scope: The hired vehicle i.e. One Non AC SUV will have to perform all the work of transportation of Sr. DEN/CO/Nagpur S.E. C. Railway in Nagpur Division along with Driver to and from and also as and when req uired, including Sundays and holidays as notified by the Railway Administration from time to time at the di scretion of Railway. - 2). In case of any conflict between GeM standard tender condition and special condition added by buyer, s pecial condition added by buyer will prevail over standard GeM condition.
- 3). Payment terms/Invoice creation by service provider:

- ii. Monthly invoice bill = Rs. [ A + C \* (Actual km run in a month as per log book)]

- iii. Consignee shall ensure that the bill raised by service provided is as per this clause of this ATC and no a ny payment will be given other than mentioned in para 3 above. Necessary penalty and deductions shall be deducted before approval of invoice in GeM. In all other cases, invoice shall be summarily rejected. Invoice shall be approved by min Gazetted officer of User/User department.
- 4). Eligibility/Documents required for Bid. In the absence of above, bid will be summarily rejected:

- ii. If offered vehicle is sublated from owner, Notarized Lease agreement between owner and bidder shall be attached with bid. In the absence of these docs wherever applicable.
- iii. Past performance of hiring of one vehicle (IREPS/GEM contract copy) to any Railway/PSU/Central/ State govt/Public listed Company in last 3 Financial year and including current year shall be attached with offer. Ongoing contracts shall also be acceptable. In the absence of performance, **the offer will be summarily rejected**.
- iv. Location of service provider doc as per clause (7)
- 5). Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the contract or any part thereof by a written notice to the Seller, i f: (i)The seller fails to comply with any material term of the contract (ii)The Seller informs Buyer of its inabil ity to deliver the Material(s)/service or any part thereof within the stipulated delivery period or such inability otherwise becomes apparent. (iii)The Seller fails to deliver the Material(s)/Service or any part thereof with hin the stipulated Delivery Period and/or to replace/rectify/ any rejected or defective Material(s)/Service promptly. (iv)The Seller becomes bankrupt or goes into liquidation. (v)The Seller makes a general assignment for the benefit of creditors (vi)A receiver is appointed for any substantial property owned by the Seller, (vii)The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
- 6). Bidder financial standing: The bidder should not be under liquidation; court receivership or similar proc eedings should not be bankrupt. **Bidder to upload undertaking to this effect with bid.**
- 7). Service & Support AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider mu st be located in the district of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED (i.e. MSE certificate , UDM, Udyam, Gumasta, GST certificate, PAN card of firm etc). (Self Declaration/Kirayanama will not be considered).
- 8). PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location as per minimum wages act / labour laws.
- 9). Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C (N ame of the Buyer). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. - 11). Duration of the service contract may be extended up to 6 months beyond the initial contract duration (subject to satisfactory performance and mutual consent).
- 12). Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regard. GST reimbursement will be as per actual or as per applicable rates (whichever is lower). subject to the maximum of quoted GST %

- 13). Vehicle should be registered in the name of Tenderer and should not sublet any part of the contract. H owever, the Tenderer can have Lease Agreement with the owner of the vehicle/cab aggregator on nonjudic ial stamp paper for the tenure of the contract, which should be submitted along with the bid. The Tenderer is required to submit the Vehicle registration details along with supporting documents of the vehicle fulfilling the category, specifications etc.
- 14). It should be stipulated that the vehicle supplied should be registered with TAXI/MAXI/CAB/Transport P ermit. Bids of other than commercial vehicles should be summarily rejected. It should have "Valid Fitness c ertificate commercial license" (Permit for Commercial Vehicles shall cover all States in S.E.C. Railway juris diction or as considered necessary by the Department/ Division/ Unit calling the tender from the appropriat e Regional Road Transport Authority of the concerned State Govt./Union Territory), valid insurance and should meet requirements of pollution standard etc. as per provisions of Motor Vehicle Act and fulfil any other statutory obligations as applicable including all safety approved accessories/equipment fitted to the vehicle. - 17). The vehicle should be available on all days including holidays.

- 20). One weekly off is permitted to the driver normally on Sundays however it may be deferred to some ot her day at the discretion of the officer in charge to whom the vehicle is attached.

- 23). Mobile phone should be provided to the vehicle driver with a smart handset.
- 24). As and when required by officers, vehicles can also be utilized for travelling outstation i.e. more than 50 Km.
- 25). Vehicle required to be parked at officer's residence or office premises.
- 26). Vehicle must have a minimum 200 km range 12 litres fuel available on each service providing a day t o avoid service interruption. Failing to above condition will be treated as not availability of services and to 5 / 7 be dealt as per the existing penalty clause available in GEM i.e' SLA clause No. 8(7) of GeM contract/ Special conditions of contract.
- 27). The contract will also be governed by GeM SLA, Buyer specific Bid ATC, and Railways GCC of service c ontract as amended from time to time by the Railway Board.
- 28). The vehicle provided will meet the latest government standards for safety and pollution i.e. minimum 5-6 or Bharat Stage VI or latest applicable or any other rules/provisions as issued by state/central government.
- 29). Service provider has no authority to question the motive/travelling movement of the officer or vehicle.
- 30). The service provider shall comply with all rules & regulations issued by state/central government from time to time, applicable to this contract.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
