1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

*** EARNEST MONEY DEPOSIT (EMD):** for **Rs. 35,000** /- is to be deposited as per following instructions, EMD other than ONLINE deposit shall not be considered:

Submit the acknowledgment / receipt of online EMD Payment / exemption proof along with your offer. EMD other than above mentioned modes shall not be considered.

Tenders received without EMD / EMD exemption proof will be considered as non-responsive and summarily rejected. No correspondence in this regard shall be entertained.

Forfeiture of Earnest Money Deposit:

If for any reason whatsoever any TENDERER withdraws his tender at any time prior to expiry of the validity period or after issue of the Letter of Intent, Purchase Order, fails or refuses to execute the order or to furnish the security deposit for faithful performance of the CONTRACT within the stipulated time the amount of Earnest Money is liable to be forfeited.

Refund of Earnest Money:

Earnest Money Deposit will not carry any interest. Earnest Money Deposited by the unsuccessful tenderers will be refunded as soon as possible. Earnest Money Deposit of successful TENDERER will be refunded after the successful TENDERER furnishes the security deposit.

*** Security Deposit Clause (SD):**

The Security Deposit for proper & timely fulfilment of the ORDER has to be submitted by successful BIDDER. No exemption will be made. Vendor will have to submit security deposit for 05% of basic contract value within 14 days from date of placement of GEM Contract order, if not submitted in 21 days EMD shall be forfeited. No exemption will be made. This SD should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier, including warranty obligations.

SD may be furnished in the form of Insurance Surety Bond, account payee demand draft, fixed deposit receipt from a commercial bank, bank guarantee issued/confirmed from RCF Approved bankers, or online payment in an acceptable form, safeguarding the purchaser's interest in all respects.

The security deposit will be forfeited and credited to the procuring entity's account in the event of a breach of contract by the contractor. It shall be refunded to the contractor without interest, after he duly performs and completes the contract in all respects but not later than 60(sixty) days of completion of all such obligations including the warranty under the contract.

*** PRE-QUALIFICATION CRITERIA FOR ACCEPTANCE OF OFFERS:**

A. Experience Criteria:

- a) Bidder should submit PO copy for supply of same or similar type of General Items / Industrial Tools supplied directly to reputed Fertilizer / Chemical / Petrochemical / Oil And Gas / Refinery / Power Plants during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following: -
 - i. **Criteria 1:** At least One Purchase order copy costing not less than the amount equal to **Rs. 8.45 Lakhs. OR**
 - ii. **Criteria 2:** Two Purchase order copies costing not less than the amount equal to **Rs. 5.28 Lakhs** each. **OR**
 - iii. **Criteria 3:** Three Purchase order copies costing not less than the amount e

qual to **Rs. 4.22 Lakhs** each.

- b) Relaxation in Experience criteria for eligible MSEs: For MSEs- Relaxation of 25% in prior experience shall be provided to the qualifying MSEs.

B. Financial Criteria:

CA certified Turnover during last three financial years (2020-21, 2021-22, 2022-23 OR 2021-22, 2022-23, 2023-24) (Required minimum Avg. turnover of **Rs. 8.45 lakh**).

Bidders shall submit CA certificate / CA audited Profit & Loss accounts...etc. indicating the annual turnover figures, in support of the same. The Turnover should be issued by practicing CA with Membership Number, seal and signed with UDIN.

In case the date of constitution / incorporation of the bidder is less than 3 years old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account. In this case, the financial turnover during last financial year / the average financial turnover during preceding two financial years should be at least Rs. 8.45 lakh.

Relaxation in Turnover criteria for eligible MSEs: For MSEs- Relaxation of 25% in Annual financial turnover shall be provided to the qualifying MSEs.

- C. Make In India Declaration:** As per revision dt 16.09.2021 of 'Public Procurement policy 2017', Non-local suppliers cannot participate in tenders having estimates less than Rs. 200 crores. Offers of **Class-I and Class-II Local suppliers** as per Make in India policy can only be considered for evaluation and award of contract. The document (Self Declaration) should be given on bidders letter head and should specify GeM Tender ID, Percentage of local content and Location (factory address) of local value addition.
