- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. - 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating

- 7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 20% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
- 10. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. 1. Generic

Running Contract for long term staggered delivery: The Purchaser reserves the right to increase the order quantity against this bid by

% of the bid quantity. This bid is created for a long term staggered delivery requirement and hence the Contract Price will be Valid for a period of

12

Months from the date of placement of contract. Total estimated requirement for all bid items during contract validity period is therefore = bid quantity plus option clause %. The buyer commits to order a minimum 50% of the quantity under option clause during the contract price validity period and the child contracts would be largely spread evenly over the contract validity period unless in exceptional circumstances. Orders for the additional quantity under this modified option clause will be issued by the buyer in the form of separate child contracts and will have to be executed by the seller as per delivery timelines stipulated by the Buyer in Child Contracts. Option of issuing child contracts may be exercised by the buyer more than once (any number of times) during the Contract Price validity period. Bidders are bound to accept the child contracts accordingly. GeM Transaction charges will be calculated based on the total value of all orders placed including the main contract and all child contracts. The same shall have to be paid by the seller when the main/ child contracts are placed.

The bidders should be bound to all the terms and conditions under Running contract for long terms staggered delive ry for a period of one year.
- 2) FOR All India basis Rates including GST must be Quoted in the price bid for 1 Kg but the material is to be supplied in 20 g packing size.

Bidders may please note that the rates received in the price bids shall be considered for the rates of 1 Kg size FOR All India basis inclusive of all taxes only. The rates should be quoted for the offered items on the basis of F.O.R destination door delivery, inclusive of GST, Packing & Forwarding charges, loading & unloading charges etc. the material is to be supplied in 20 g packing size

- 3) If the bidder has not submitted the their Own CIB & RC License and Manufacturing License for particular item, they may be considered as dealer/Trader/reseller. So if applicable, EMD payment is mandatory for Trader/ dealer/reseller in that case as per MSE policy.
- 4) The seller shall upload/furnish the following documents along with their bid:
- 1. Registration certificate issued by Directorate of Plant Protection, Quarantine and Storage (CIB)
- 2. Valid manufacturing license issued by the authorized government agency.
- 3. Bidder should submit the Undertaking of Technical source of chemical. Submission of Undertaking of Technical source of chemical is mandatory.
- 4. Authority letter from the manufacturer in case of authorized distributor.
- 5. Self Attested photo copy of registration certificate duly quoted registration no. in case of Micro & S mall Enterprises (MSEs).

- 5) Post delivery test:-It is understood and agreed by the contractor that three joint samples will be drawn after the stores are received at the destination and got sealed. For this purpose, the firm should send their representative for drawing samples within a reasonable period of three days of receipt and in case the representative dose not report himself for drawing the samples, the samples shall be drawn by the farm/ office authorities and the samples
- so-drawn shall be taken as final and no dispute on this account shall be accepted that the samples were not drawn in the presence of the representative of the firm and hence might not have been d rawn in a proper manner. Out of the said samples, one such sealed sample will be retained each by the contractor and the purchaser and the third will be sent for analysis. The payment will be released only if the test reveals that the material is as per the BIS specifications laid down. In case the supply made is substandard, the stores shall be removed by the supplier at his own cost within se ven days from the receipt of a communication from the purchaser to this effect. Post Delivery Lab testing charges of the samples of chemical shall be borne by the supplier only.
- **6) Submission of Undertaking of hiring of formally certified skilled workforce** or commit ment by the vendor/ bidder/ service providers mentioning that they would ensure all their workers would be skilled through Recognition of Prior Learning (RPL) within Two months from date of commencement of work under the project at the cost of Service provider/ Vendor which is to be submitted by the bidders however it is not mandatory for the bidder to submit the Undertaking of hiring of formally certified skilled workforce under RPL mission.
- **7) Replacement of item:-** The seller shall lift and replace the lot at his own cost, if the samples f rom the received lot at consignee end fail during testing. Lot will be accepted on being found in conformity during testing. testing charges of the samples of the chemical for the second time after replacement shall be borne by the supplier only.
- 8) <u>The lab testing charges shall be recovered from the payment of the bills of the supplier.</u>
- **9)** The delivery period shall be 60 days from the issuance of purchase order. It would be clearly understood that any delay in delivery will cause unascertainable damages to the Corporati on. Only those parties should tender who are in a position to stick to the delivery prescribed. Their attention is also relating to liquidated damages which shall be binding. The delivery period shall be 60 days from the issuance of purchase order.

- **11)** Destination and quantity may be varied as per the requirement of chemical on need basis. Su pplier should supply the chemical as per the requirement to the respective destination on need basis. Supplier should supply the chemical as per revised destination and quantity given by NSC. The actual supply address shall be provided after the placement of Purchase Order. Consignees destinations may vary in Child Contracts to be placed for future supply.
- **12)** Since the requirement of chemical is time bound, if there is any delay in the supply of chemic al may lead to huge loss to the Buyer. Taking into consideration of the above matter, NSC holds the right to debar the supplier on the basis of the following:
- a. Delay in supply of chemical for a long period, which led to huge financial loss.

b. Improper or wrong quote of price- if the rates quoted are not according to the prescribed packin g size rate of **1 Kg/Lt.**

c. Wrong quote of GST.

Arbitration Clauses

In case any dispute arises between NSC and the other party due to any term or matter, both the parties wil I opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discus sions, then it shall be binding upon parties to resolve issues under the provisions of Arbitration & Conciliati on Act, 1996 as amended from time to time. Under this provision, the Chairman-cum-Managing Director, N ational Seeds Corporation Limited with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve thi s dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall be in English Language. The court of Delhi shall have the jurisdiction.

As per the Guidelines of Arbitration & Mediation in Contracts of Domestic Public Procurement issued by Th e Department of Expenditure Procurement Policy Division under Ministry of Finance, Govt. of India through OM No. F.1/2/2024-PPD dated 03.06.2024, the arbitration shall be restricted to disputes with a value less t han Rs. 10 crore. This figure is with reference to the value of the dispute (not the value of the contract, whi ch may be much higher). In all other cases where value of dispute is above 10 crore, arbitration will not be a method of dispute resolution in the contract."

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. - 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
