1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 3. Generic

Loading and Unloading at yard will be under the scope of the supplier.

#### 4. Scope of Supply

### **Buyer added Bid specific ATC (Additional Terms & conditions) to be complied by the interested Bidders for prequalification**

1. The bidder must be a manufacturer/ principal of authorized representative of manufacturer (hereinafter referred simply as the "The Bidder") of different types of Pulleys /conveyor spares like idlers/ rollers and/or roller stands. They need to submit the documentary evidence like Registration with NSIC/SSI/ DG S & D or any other Government Bodies towards manufacturing of above items. The principal of authorized representative of manufacturer to submit the authorization certificate in their favour from manufacturer along with documentary evidence of their principal as manufacturer.
2. The bidder must have executed Purchase Orders showing supply of different types of Pulleys /conveyor spares like idlers/ rollers and/or roller stands to any PSU/Port Authority/Govt. Organization/Reputed Private Organization during last 03 years ending Dt.31.03.2024 in either of the following 03 categories:
  - i. 03 Purchase Orders, each of value not less than Rs. 11,30,000/- only excluding GST
  - ii. 02 Purchase Orders, each of value not less than Rs. 14,12,500/- only excluding GST
  - iii. 01 Purchase Order, of value not less than Rs.22,60,000/- only excluding GST

The bidder must submit purchase order copies along with performance / acceptance certificate/ invoice copies against specific order copies submitted in support of successful execution of submitted orders

3. The bidder must be financially sound. The bidder must have an average annual turnover of Rs. 11,30,000/- or more during last 03 financial year ending on 31.03.2023. The supporting document in this regard i.e. an affidavit/ certificate from Chartered Accountant/ Cost Accountant /audited copy of profit & loss account sheet/ balance sheet showing turnover during the above period to be submitted.
4. The bidder must confirm to supply as per technical drawings & QAP as given in the Bid (Reference- Specification document file uploaded in the Bid document).
5. The bidder must confirm their acceptance for the inspection of the materials along with required acceptance/routine tests at their works by a 3rd party i.e. RITES/CEIL/PDIL, during manufacturing & final stage confirming to drawings & QAP approved by PPA at their cost. They must submit all the test & inspection reports duly signed and accepted by 3rd party along with dispatch clearance certificate with the supply of Rollers & Roller stands.
6. The bidder must confirm to abide by all the terms and condition of bid including delivery, buyer added specific ATC, General terms and conditions of Bid and payment within 30 days after receipt and acceptance of supplied Rollers & Roller stands along with submission of all the required test reports and other documents in line of Contract /Order.

7. The bidder must confirm the guarantee of the supplied Rollers & Roller stands for a period of 18 months from the date of supply or 12 months from the date of installation/put to operation whichever is earlier against defective design/ workmanship/quality. Any defect / damage found in the Rollers & Roller stands during the above guarantee period shall be replaced /rectified free of cost. A guarantee certificate in this regard to be submitted at the time of supply. The S.D shall cover the entire guarantee period and encashability for a further period of 02 months after expiry of guarantee period.
8. The bidder must confirm to submit e-PBG of 05% of Contract /Order value in shape of Bank Draft from any Nationalized Bank favoring FA&CAO., Paradip Port Authority or Bank Guarantee in the prescribed format, to be given by purchaser from any nationalize Bank within 15 days from the date of purchase order. If after depositing the Security Deposit, the successful bidder fails to supply the materials within the scheduled time, the Purchase Order shall be liable for cancellation forfeiting the Security Deposit. The security deposit submitted in shape of Bank Draft or Cash/ Bank Guarantee shall have to remain valid over 02 months from expiry of the Guarantee Period.

NB:- The participated bidders shall be technically prequalified basing on compliances to above Terms.

## **Disclaimer/अस्वीकरण**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to

such representations.
