1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from "Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in the Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises. If the bidder wants to avail the Purchase preference for services, it must be for the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered Service. MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band. The order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are : [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the bidder is registered on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price of the bid also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining the award. The award would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices.
7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three financial years and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost of the project.
 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost of the project.
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost of the project.
8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1.
 - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1.
