Replacements of Goods Broken, Damaged** or Short If whole or part of the goods/equipment suppli ed against the order is found defective/ non-functional or without specification the supplier will have to rep lace the defective goods/ equipment to make equipment operational within a reasonable time (not exceed ing two month from the date of intimation to the supplier or the Indian Agent), failure to which the supplier will have to refund the full cost of the equipment including freight, Insurance etc.
- 18. **Only one price** bid should be submitted for the above equipment. A bidder, who submits more than o ne price bid, shall be disqualified and considered non-responsive.
