Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and

its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. No relaxation or exemptions will be provided in respect of other pre-qualification criteria, including technic al requirements.

Once pre-qualified, they will be considered on par with other bidders for price bid opening, e-rever se auction, and order placement.

Category 2 (Additional Quantity): D)

Start-up bidders who offer an additional 10% quantity without submission of any pre-qualification docume nts will be considered only for this additional quantity.

- Their price bid will not be opened.
- They will be given the option to match the lowest rate (L-1).
- The 10% additional quantity will be awarded subject to matching the L-1 price.

E) Multiple Qualifying Bidders:

If multiple start-up bidders qualify under Category 2, the 10% additional quantity will be equally distributed among all qualifying start-ups, provided they match the lowest rate.

F) Important Note:

Bidders must select their category at the time of bid submission. This selection cannot be changed during any further stage of the tender.
