1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or

through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

**1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

**2. Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

**3. Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

**4. Buyer Added Bid Specific ATC**

**Buyer Added Bid specific Terms and Conditions**

- The laptops shall be supplied in compliance to the specifications mentioned in the Bid document on Ge M Portal.
- The successful bidder shall be responsible for unboxing the laptops on-site and shall arrange activation of the laptops with valid operating systems (Mac)
- The supplier shall provide packing of the goods, as is required to prevent their damages or deterioration during the transit to their final.
- The Supplier shall replace with new laptop systems if it is found damaged at the time of delivery and the replaced laptops shall be delivered within due delivery period i.e. within 45 days from the date of award.
- The rates quoted shall be firm & all-inclusive for delivery & installation at destination
- Delivery Time: The Purchaser expects to have delivery of all items as per BoQ within 15 days from placing the Contract on the GeM portal and the same can be extended for the successful Bidder for a maximum of 10 days upon request by the Successful Bidder stating genuine reasons.
- Bidder should submit Last 03 Financial Years (FY 2020-21 to FY 2022-23) IT Returns and Turnover Certificates on CA Letter Head with UDIN number.

- h) Bidder should submit latest GST Return for the last 03 months along with the bid documents.
- i) PAN & Odisha GST Registration Certificate must be submitted by the bidder.
- j) Bidder must have a registered Office in Bhubaneswar, Odisha.
- k) Buyer shall have reserved the rights to accept or reject the bid without assigning any reason thereof.

## **Disclaimer/अस्वीकरण**
