- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

- 6. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.
- 7. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N

sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

Additional Terms and Conditions for Hiring of Drivers

The Lok Sabha Secretariat shall hire 10 Drivers initially for a period of **ONE**

YEAR on **DEMAND BASIS on RATE CONTACT**. The demand of Drivers may be increased/decreased as per requirements.

- The bidder shall quote separate rate as well for hiring of drivers on per day basis (for use during events/exigencies).
- The engagement period may be considered for further extension on year to year basis with mutual consent, based on performance and requirement.
- Earnest Money Deposit (EMD) of requisite amount of Rs.53,100/- (Rupees Fif ty Three Thousand and One Hundred Only) as per bid details on GeM portal to be deposited in form of Demand Draft favouring "DDO, Lok Sabha" latest by closing date and time of the bidding at Central Transport Management Cell, Room No. 627, Lok Sabha Secretariat, Parliament House Annexe, New Delhi 110 001. The same should be valid for 45 days beyond the bid validity. No interest shall be payable upon the Bid Security / EMD or any other amounts payable by the Seller to the Buyer under the Contract. The EMD must be sub mitted before last date of submission of tender as per GeM Portal. However, firms registered with MSME, Central Purchase Organisation/National Small In dustries Corporation (NSIC) are exempted from depositing of EMD. Such firm s are required to upload the relevant copy of exemption certificate issued by the competent authority.
- Drivers should possess a valid driving license for light motor vehicles (LMV).
- Regular duty hours shall be from 9:00 AM to 7:00 PM. from Monday to Satur day.
- Drivers may be required to report before 9:00 AM and/or stay beyond 7:00 PM in case of exigencies.
- For hours beyond regular duty, Overtime Allowance (OTA) shall be provided by the Service Provider as per labor law and claimed in the invoice with valid proof.
- Service provider should ensure that Drivers should have a minimum of 3 ye ars of driving experience.
- Drivers must be physically fit, possess good eyesight, and be free from any criminal record.
- Drivers shall wear neat and clean uniforms provided by the Service Provider .
- They must maintain courteous behavior, adhere to traffic rules, well acquain ted with NCR area and avoid reckless driving.
- Drivers shall ensure proper handling and cleanliness of the vehicles assigne d to them.
- Any negligence resulting in damage to vehicles shall be the responsibility of the Driver or Service Provider.
- All drivers have live mobile phone connection so that they can be contacted whenever required.

- Arrange to provide replacement of the designated driver, in case of perform ance being found not upto the standard.
- The Service Provider shall ensure compliance with all applicable labor laws, including payment of minimum wages, EPF, ESI, and other statutory benefits to the Drivers.
- Any non-compliance will result in penalties or cancellation of the agreement as per SLA.
- The terms and conditions mentioned in Service Level Agreement which is available on GeM Portal will be applicable to both the parties (Buyer and Service Provider)
- The bidders shall have to furnish the self attested copies of income tax return for the last three financial years as supporting documents related to turnover.
- The bidders shall have to provide proof of their office (leased/owned) in Delhi NCR.
- The bids from individual/firm/organization including its partners/shareholder s/directors who have been blacklisted/prosecuted by any departments/statut ory bodies in any state or by any court of law, shall not be entertained. An undertaking on the letter head of the Company as per the specimen given in Annexure-I is required to be submitted along with Technical Bid.
- Lok Sabha Secretariat shall have the discretion of termination of the contract t entered into at any point of time during the contract period without any pri or notice.
- All disputes, differences and questions arising out this contract or subject m atter thereof of the representative rights, duties or liability of the parties shall referred to the sole arbitration of the Secretary General, Lok Sabha or a ny person nominated by him. The arbitrator shall be entitled to extend the time of arbitration proceedings with consent of the parties. No part of the engagements shall be suspended on the grounding pending arbitration proceedings.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्ते</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
