  - d) Bidder and/or any of its allied entity(ies), which directly or indirectly co ntrol(s) or is(are) controlled by or is(are) under common control of ano ther entity, has(ve) participated as a consultant in the preparation of t he design or technical specifications of the contract that is the subject of the tender; or
  - e) Bidder participates in more than one bid in this bidding process.
  - f) In cases of agents quoting on behalf of their principal manufacturers/ service providers, one agent cannot represent two manufacturers/service providers or quote on their behalf in a particula r tender enquiry. One manufacturer/service provider can also authoriz e only one agent. There can be only one bid from the following:
