1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 3. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are

advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 <u>OM_No.1_4_2021_PPD_dated_18.05.2023</u> for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Buyer Added Bid Specific ATC

<u>1]</u> Performance Security (e-PBG) : After placement of order, Supplier shall submit performance Bank G uarantee for 3% of order value as per GeM GTC valid till delivery period plus Guarantee period plus 60 day s.

2] Liquidated Damages: The Delivery Date stipulated in this order is the essence of the Contract. You sh ould adhere to the delivery schedule as stated above and execute the order before the stipulated date. Inc ase of delay, Liquidated damages @ 0.5% (Half Percent) of the value of undelivered portion per week or pa rt thereof, Subject to a maximum of 10% of the total contract value will be levied.

3] Please provide compliance to all the terms and conditions, Technical Specifications, mentioned in the G eM bid specification document along with documentary evidence duly filled and signed as a token of accep tance for the same. otherwise your bids are liable to be rejected.

4] Bidders must fill up all the schedules and annexure and furnish all the required information as per the in structions given in various sections of the tender specification. Each and every page of the tender specifica tion must be SIGNED AND SUBMITTED ALONG WITH THE OFFER by the bidder in token acceptance thereof. The information furnished shall be complete by itself.

6] Price of any Kind shall not be disclosed in the technical bid otherwise the offer will be summarily rejecte d.

7] Items will be inspected by the Department after the delivery at site. If it is not found in appropriate con dition or it is from the old stock or falls to meet the desired specifications, Item will be rejected. Subsequen tly, the supplier has to replace the item with a new batch at the supplier's cost.

8] Guarantee: The body constructed should be guaranteed for a period of one year from the date of deliver y of built vehicle or before such vehicle has been driven 40,000kms whichever event occur first against all manufacturing defects, faulty workmanship, sub-standard materials etc., During this period, if any defects are noticed, supplier has to rectify /replace them at free of cost within reasonable time. A warranty certific ate should be provided along with other documents at the time of delivery.

9] **TRANSPORTATION:** Chassis shall be collected from SDSC SHAR, Sriharikota by the successful bidder and shall be delivered back to Central Stores, SDSC SHAR, Sriharikota after completion of body fabrication work. The vendor should ensure safe transportation and also has to obtain the all the necessary document s like Temporary registration/Trade certificate and transit insurance etc., at his own cost for transportation of both chassis and finished vehicle.The purchaser will not pay separately for transit insurance and same s hall be included in the cost quoted by the VENDOR. All risks in transit shall be exclusively borne by the vendor and the purchaser shall pay only for such items as are actually received in good condition in accordance with the purchase order.

Invoice and all documents related for registration of vehicle should be supplied by the party on 'Director, S DSC SHAR, Sriharikota' and all the correspondence to "Sr. Head, Purchase and Stores, SDSC SHAR".

10] BANK GUARANTEE : Since the vehicle is the property of Govt. of India, for keeping the vehicle at ve ndors site, vendor has to furnish a Bank Guarantee/Security Deposit from a Nationalized/Scheduled Bank t owards the cost of the Chassis on Rs. 200/- Stamp Paper for the custody of the vehicle (Rs. 16,50,516/-) val id up to the period of delivery of vehicle at our site. The vehicle shall be given to vendor only on receipt of the Bank Guarantee.

11] Items shall be delivered on working days only (Monday to Friday) excluding Public Holidays and during working hours (from 10:00 AM to 04:00 PM).

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
