1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Not submitting the same will result in rejection of the bid.

(10) Loading/Unloading of items from vehicle shall be the responsibility of the vendor to respective locatio n in SAC, Ahmedabad.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
