If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide

eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

#### 3. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

### 4. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 25% of total value.

### **SPECIAL CONDITIONS:**

- A) Any deviation from our specifications shall be mentioned in the offer itself.
- B) Performance curves of offered pumps shall be submitted along with the offer.
- C) Dimensional GA drawing, CS drawing with parts list and MOC shall be submitted by qualified L1 bidder f

or our approval before placement of order.

- D) Pump shall be provided with the following:
- a) Suitable lifting aids such as eyebolts, lugs, jackscrew etc. to facilitate disassembly and handling.
- b) Cast in or permanently attached arrow indicating the direction of rotation.
- c) A corrosion resistant Nameplate shall be permanently attached to indicate Manufacturer's name, Serial no & Model No, rated capacity & head, Speed in RPM, Drivers rating etc.
- E) PDI shall be done by FACT / FACT authorized agency(TPI)at vendor's works before dispatch. Cost of PDI shall be borne by FACT. All testing facilities, tools, tackles and measuring instruments shall be arranged u nder vendor's scope. Scope of PDI is as follows:
- a) Verification of material test certificates and dimensional inspection
- b) Witnessing and verification of performance tests based on performance curves and hydro tests on all the offered pumps with suitable test motor.
- c) Witnessing of Vibration and Sound level test (< 85 dB)
- d) Witnessing of Bearing check, Mechanical seal check, clearance check and casing inspection during dism antling inspection immediately after performance tests.
- F) The following shall be furnished along with the supply:
- a) Operation, maintenance and spare parts manual including cross sectional drawing with list of parts, mat erial of construction etc.
- b) Material test certificate showing chemical composition and physical properties.
- c) Performance and hydraulic test reports conducted on the pump.
- G) One set of complete mechanical seal assembly with gland plate against three pumps altogether as man datory spares shall be submitted along with bid offer. Mandatory spares shall be supplied along with offered pumps.
- H) Pump shall be guaranteed against poor material/workmanship for a period of 12 months from the date of use or 18 months from the date of despatch, whichever is earlier.
