1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of PAN Card.
- Copy of GSTIN.
- Copy of Cancelled Cheque.
- Copy of EFT Mandate duly certified by Bank.

4. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

5. Buyer Added Bid Specific ATC

Part- A: FOR INSTRUMENT:

A. BID EVALUATION:

Bidder has to quote for Equipment and its AMC part separately (as per BOQ). Bid evaluation will be done on package basis (for overall L1).

B. Consumables and accessories: Instrument should be supplied with the following mandatory standards and consumables

1. (a) Water standard 0.01%, Make: Merck or any make low water content standard, traceable to NIST, Quantity: 10 Ampules.

(b) Water standard 0.1%, Make: Merck or any make high water content standard, traceable to NIST, Quantity: 10 Ampule.

Standards of other than Merck make are acceptably only if the calibration of quoted instrument is not possible with our specified standards.

2. Reagent minimum 1.0 litre with packing size of 500 ml or less

C. OTHER TERMS & CONDITIONS:

1. Free/standard Warranty period 01 year (minimum) will start from the date of successful installation/commissioning of the instrument at our site & submission of certificate with material delivery is mandatory.

2. Service under free/standard warranty shall consist of corrective maintenance work and replacement of defective parts of all types.

3. The supplier must install and commission the instrument successfully at our site and train our persons to run the instrument independently. No separate payment will be done for this.

4. The instrument shall be accompanied by O&M Manuals.

5. BG retention period for supply section will be 01 year after successful installation & commissioning of instrument.

6. Payment T&C : 90% against successful commissioning, demonstration and training at NSPCL site. Balance 10% on submission of PBG.

7. Separate POs will be awarded for supply and AMC part at separate time. AMC part PO will be awarded after completion of 01 year warranty period.

PART- B: FOR ANNUAL MAINTENANCE CONTRACT (AMC) OF THE INSTRUMENT:

The scope of work for the Annual Maintenance Contract shall cover extended warranty service for an additional period of two years from the date of expiry of normal/ standard/free warranty period.

SCOPE OF WORK AND TERMS & CONDITIONS FOR AMC:

1. Service under AMC shall consist of corrective maintenance work. Spare part and consumables shall be in the scope of NSPCL.

2. Agency's authorised Service Engineer shall make two visit (preventive/Breakdown maintenance) per year during AMC period. Breakdown maintenance means sudden malfunctioning of the equipment.

3. In case of such breakdown, service engineer shall attend the instrument within five days from the date of intimation from site.

4. No separate TA/DA/ boarding charges will be paid to the vendor for service visits. Service engineer shall have to make his own arrangement for accommodation and conveyance during service visits.

5. Payment shall be made on per service visit basis against the invoice raised by vendor per visit basis. Taxes extra as applicable.

6. Contract Period: Two years (starting immediate after the date of expiry of normal/ standard/ free warranty period).

7. Defect Liability Period for Services: 30 days.

8. SD clause will be applicable as per NSPCL rules.

Termination of the Contract:

NSPCL reserves the right to foreclose or terminate the AMC contract in part or full with a month notice, at any point of time during the contract period, if supplier fails to perform satisfactory services.

Note: "Additional Specifications, Buyer Added Bid Specific Terms & Conditions, Attachments (if any) along with Tender specifications shall be deemed unconditionally accepted by bidders, unless there are specific representation/s and clarification/s prior to bid submission in GeM portal".

7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
