- 1. In the absence of receipt of Pre-qualif ication criteria, the offer will not be considered under any circumstances.

NB: Successful bidder shall engage manpower from local area i.e. within 6 km from plant premises (Pre ferably).

II) Note: As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Procurem ent of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During evaluation and co mparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The r equest for clarification shall be given asking the tenderer to respond by a specified date. If the tendere r does not comply or respond by the date, his tender will be liable to be rejected. Depending on the out come, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted. No post bid clarification at the initiative of the bidder shall be ent ertained. The shortfall information / documents should be sought only in case of historical documents which pre-existed at the time of the tender opening and which have not undergo ne change since then. So far as the submission of documents is concerned with regard to qualification criteria, after submission of the tender, only related shortfall documents should be asked for and considered. For example, if the bidder has submitted a supply order without its completion / performance certificate, the certificate can be asked for and considered. III)As per section 7.3.1 of Manuals for procurement of Goods, the offer shall be declared as unresponsive and be ignored during the initial scrutiny if:

- a) The offer is not in the prescribed format or is unsigned or not signed as per the stipulations in the bid document.
- b) The required EMD has not been provided or exemption from EMD is claimed without acceptable proof of exemption;
- c)The bidder is not eligible to participate in the bid as per laid down eligibility criteria(example: the tender enquiry condition says that the bidder has to be a registered MSE unit but the tenderer is a, say, a la rge scale unit);
- d) The tenderer has quoted for goods manufactured by a different firm without the required authority lett er from the proposed manufacturer.
- e) The bid departs from the essential requirements specified in the bidding document (for example, the tenderer has not agreed to give the required performance security); or
- f) Against a schedule in the list of requirements in the tender enquiry, the tenderer has not quoted for the entire requirement as specified in that schedule (example: in a schedule, it has been stipulated that the tenderer will supply the equipment, install and commission it and also train the purchaser's operators for operating the equipment. The tenderer has, however, quoted only for supply of the equipment).

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
