- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. ### **Part-I - General Information**

**1.** <u>Last Date and Time of depositing the Bids</u>: The online bids should be uploaded by due date and ti me. The responsibility to ensure lies with the bidder.

- 2. <u>Manner of depositing the Bids</u>: Online bids should be scanned and uploaded before due date and ti me. Late tenders will not be considered. No responsibilities will be taken for technical delay or not uploading of bid documents. Bids sent by fax/ email will not be considered.

- **9.** Clarification regarding contents of the Bids: During evaluation and comparison of bids, the Buyer may, at its discretion, ask the bidder for clarification of his bid. The request for clarification will be given in writing and no change in prices or substance of the bid will be sought, offered or permitted. - 1. <u>Law:</u> The contract shall be considered and made in accordance with the laws of the Republic of Indi a. The contract shall be governed by and interpreted in accordance with the laws of the Republic of India.
- **2.** <u>Effective Date of the Work Order:</u> The contract shall come into effect on the date of signature of bo th the parties on the contract (Effective Date) and shall remain valid until the completion of the obligations of the parties under the contract. The deliveries and supplies and performance of the services shall comme nce from the date of the contract.
- **3.** <u>Arbitration</u>: All disputes or differences arising out of or in connection with the Contract shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or relating to the contract or relating to construction or performance, which cannot be settled amicably, may be resolved through arbitr ation. The standard clause of arbitration is as per Forms DPM-7, DPM-8 and DPM-9 (available in MoD websi

te and can be provide on request).

- 4. Penalty for use of Undue influence: The Seller undertakes that he has not given, offered or promise d to give, directly or indirectly, any gift, consideration, reward, commission, fees, brokerage or induceme nt to any person in service of the Buyer or otherwise in procuring the Contracts or forbearing to do or for h aving done or forborne to do any act in relation to the obtaining or execution of the present Contract or an y other Contract with the Government of India for showing or forbearing to show favor or disfavor to any p erson in relation to the present Contract or any other Contract with the Government of India. Any breach o f the aforesaid undertaking by the Seller or any one employed by him or acting on his behalf (whether with or without the knowledge of the Seller) or the commission of any offers by the Seller or anyone employed b y him or acting on his behalf, as defined in Chapter IX of the Indian Penal Code, 1860 or the Prevention of Corruption Act, 1986 or any other Act enacted for the prevention of corruption shall entitle the Buyer to ca ncel the contract and all or any other contracts with the Seller and recover from the Seller the amount of a ny loss arising from such cancellation. A decision of the Buyer or his nominee to the effect that a breach of the undertaking had been committed shall be final and binding on 176 the Seller. Giving or offering of any gift, bribe or inducement or any attempt at any such act on behalf of the Seller towards any officer/employ ee of the Buyer or to any other person in a position to influence any officer/employee of the Buyer for sho wing any favor in relation to this or any other contract, shall render the Seller to such liability/ penalty as t he Buyer may deem proper, including but not limited to termination of the contract, imposition of penal da mages, forfeiture of the Bank Guarantee and refund of the amounts paid by the Buyer.
- 5. Agents / Agency Commission: The Seller confirms and declares to the Buyer that the Seller is the ori ginal manufacturer of the stores/provider of the services referred to in this Contract and has not engaged a ny individual or firm, whether Indian or foreign whatsoever, to intercede, facilitate or in any way to recom mend to the Government of India or any of its functionaries, whether officially or unofficially, to the award of the contract to the Seller; nor has any amount been paid, promised or intended to be paid to any such i ndividual or firm in respect of any such intercession, facilitation or recommendation. The Seller agrees tha t if it is established at any time to the satisfaction of the Buyer that the present declaration is in any way in correct or if at a later stage it is discovered by the Buyer that the Seller has engaged any such individual/fir m, and paid or intended to pay any amount, gift, reward, fees, commission or consideration to such perso n, party, firm or institution, whether before or after the signing of this contract, the Seller will be liable to r efund that amount to the Buyer. The Seller will also be debarred from entering into any supply Contract wi th the Government of India for a minimum period of five years. The Buyer will also have a right to consider cancellation of the Contract either wholly or in part, without any entitlement or compensation to the Seller who shall in such an event be liable to refund all payments made by the Buyer in terms of the Contract alo ng with interest at the rate of 2% per annum above LIBOR rate. The Buyer will also have the right to recov er any such amount from any contracts concluded earlier with the Government of India.
- **6.** Access to Books of Accounts: In case it is found to the satisfaction of the Buyer that the Seller has e ngaged an Agent or paid commission or influenced any person to obtain the contract as described in claus es relating to Agents/Agency Commission and penalty for use of undue influence, the Seller, on a specific r equest of the Buyer, shall provide necessary information/ inspection of the relevant financial documents/in formation.
- **7.** <u>Non-disclosure of Contract documents</u>: Except with the written consent of the Buyer/ Seller, other p arty shall not disclose the contract or any provision, specification, plan, design, pattern, sample or informa tion thereof to any third party.
- **8.** <u>Liquidated Damages:</u> In the event of the Sellers's/ contractor to complete the scope of work as specifi ed in part II of Para 2. The Buyer may at his discretion withhold any payment until the completion of the contract. The buyer may also deduct from the seller as agreed. Liquidate damages to the sum of 0.5 % of the contract price of the delayed/ undelivered services mentioned above for every week of delay or part of a w eek, subject to the maximum value of the liquidated damages being not higher than 10 % of the value of the delayed services.
- **9.** <u>Termination of Contract</u>: The buyer shall have the right to terminate this contract in part or in full in any of the following cases:
  - a. The delivery/ services of the material is delayed for causes not attributable to Force Majeure for more than **(02 months)** after the schedule date of delivery.
    - (b) The seller is declared bankrupt or becomes insolvent
    - (c) The delivery of material/ services is delayed due to causes of Force majeure by more than 02 M onths) provided Force Majeure clause is included in contract.

- (d) The buyer has noticed that the seller has utilized the services of any Indian/Foreign agent in get ting this contract and paid any commission to such individual /company etc.
- (e) As per decision of the Arbitration Tribunal.
- **10**. <u>Notices</u>: Any notice required or permitted by the contract shall be written in the English language and may be delivered personally or may be sent by FAX or registered pre-paid mail/airmail, addressed to the la st known address of the party to whom it is sent.
- **11.** <u>Transfer and Sub-letting</u>: The Seller has no right to give, bargain, sell, assign or sublet or otherwise dispose of the Contract or any part thereof, as well as to give or to let a third party take benefit or advanta ge of the present Contract or any part thereof.
- **12.** Patents and other Industrial Property Rights: The prices stated in the present Contract shall be d eemed to include all amounts payable for the use of patents, copyrights, registered charges, trademarks a nd payments for any other industrial property rights. The Seller shall indemnify the Buyer against all claim s from a third party at any time on account of the infringement of any or all the rights mentioned in the pre vious paragraphs, whether such claims arise in respect of manufacture or use. The Seller shall be responsi ble for the completion of the supplies including spares, tools, technical literature and training aggregates ir respective of the fact of infringement of any or all the rights mentioned above.
- **13.** <u>Amendments</u>: No provision of present Contract shall be changed or modified in any way (including th is provision) either in whole or in part except by an instrument in writing made after the date of this Contract and signed on behalf of both the parties and which expressly states to amend the present Contract.

### 14. Taxes and Duties:

The Consumer shall not be making any additional paym ents towards satisfaction of such taxes.

- (a) Neither Party shall bear responsibility for the complete or partial non-performance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the present contract.), if the non-performance results from such Force Majeure circumstances as Flood, Fire, Earth Quake and other acts of God as well as War, Military operation, blockade, Acts or Actions of state authorities or any other circumstances beyond the parties control that have arisen after the conclusion of the present contract.
  - b. In such circumstances the time stipulated for the performance of an obligation under the pr esent contract is extended correspondingly for the period of time of action of these circumst ances and their consequences.
- 9. <u>Inspection Authority:</u> The inspection will be carried out by Commanding Officer25. The mode of Inspection will be User Inspection.
- **10.** <u>Warranty</u>: The successful bidder has to withstand warranty for a duration of 06 months w.e.f. the day of completion of job. The successful bidder will be liable to dock the ship in case of failure of welding etc.
