In the absence of receipt of Pre-qualification criteria, the offer will not be considered under any circumstances.

The offers of the bidders who have defaulted in the past in execution of the contracts or in co mplying with the obligations as per the contract of IREL (India) Limited shall not be considere d.

N.B:- (i) Interested bidders may visit the site to understand the scope, volume and category of works and witness site condition before participating in the tender.
