Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of

purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

1. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

*** PRE-QUALIFICATION CRITERIA FOR ACCEPTANCE OF OFFERS:**

A. Experience Criteria:

1. The bidder shall be original equipment manufacturer (OEM) for orifice plates.
2. The bidder, must have designed, manufactured and supplied orifice plates to chemicals/fertilizers industries and the same shall be operating satisfactorily after installation continuously at least for two years. As a documentary proof, the bidder shall submit self-attested photo copies of following documents:
 - a) Copy of Purchase Orders with full technical details of orifice plates
 - b) Certificate from user regarding satisfactory performance of orifice plates & integral orifice after installation at least for two years is preferred.

TECHNICAL CONDITIONS:

- 1) **Guarantee/ Warranty clause:** Guarantee / warranty for the product for a period of 12 months from the date of commissioning or 18 months from the date of supply whichever is earlier.
- 2) Delivery period for supply of material shall be **12 weeks from date of PO**
