1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. - 10. Bidders have to submit undertaking on Rs.100 stamp from Executive Magistrate, that they have not be en blacklisted / debarred in any organization for supply of material or services or for any other reason. The certificate should be issued after bid publication.
- 11. During the Technical OR Financial Evaluation, if department found that submitted documents are forge d & misleading then tender will be rejected & firm will be rejected for further 2 years in ULB & will be reported to Head Quarter for further action
