Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and

its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

#### **1. Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

#### **2. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### **3. Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. Payment Terms: 100% payment within 30 days of receipt & acceptance of the material at NFL Panipat Stores.
2. Bidder should submit Guarantee/ Warranty certificate against poor workmanship, defects etc. for a period of 12 months from date of installation/commissioning or 18 months from date of supply whichever is earlier along with supply.
3. Bidder should submit interchangeability certificate for the new flow element assembly, confirming that supplied item is interchangeable with the existing installed at NFL site along with supply.
4. Bidder to confirm that no change in existing pipeline will be done.
5. Bidder to confirm that supplied flow element assembly shall be retracting type i.e. with provision for online insertion/removal from line.
6. Bidder shall submit material test certificate, DP test certificates for all weld joints, hydro test certificate, dimensional inspection reports and work test certificates of supplied item along with supply of material at free of cost.
7. Bidder to perform Wet calibration for flow element and calibration reports/certificates to be submitted along with supply of material.
8. Bidder submit Datasheet, Sizing sheet, dimensional drawing of new offered Averaging pitot tube (Annubar) along with their offer.
9. During installation if any assistance is required, bidder to provide this assistance by arranging visit of service engineer at free of cost.
10. Bidder shall submit duly signed and stamped copy of complete Specification document as a token of acceptance of the same.
11. Bidder shall submit duly filled self certification form(Given in the ATC document) along with their offer.
