1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

Bidders are required to deposit an EMD of Rs. 35,000.00(Thirty Five Thousand Rupees only) in the first

instant itself at the time of offer submission only in the concerned packet. Any offer without EMD shall be treated as non-responsive offer and shall be rejected summarily. 6) If for any reason whatsoever any tenderer withdraws the tender at any time prior to expiry of the validity period or after issue of the letter of intent, purchase order, fails or refuses to execute the order or to furnish the security deposit for faithful performance of the contract within 14 days from the date of purchase order then, amount of earnest money is liable to be forfeited.

7) Security Deposit (SD):

Vendor will have to submit security deposit for 5.00% of contract value either in the form of bank guar antee as per RCF's format or through RTGS/NEFT. This SD should be covering the delivery period plus 3 months. <u>This is to be submitted within 14 days of placement of order.</u> Bank guarantee should be fro m the lists of RCF approved bankers only.

8) Performance Guarantee:

Successful bidder will be required to submit performance bank guarantee for same value as that of sec urity deposit within 15 days from the date of supply of material in the form of bank guarantee as per R CF format from RCF approved banker covering the period of 21 months from the date supply. SD subm itted in the form of bank guarantee can be converted in to PBG.

- 9) Time Frame shall be as follows:
 - a) After issuing the PO, within 14 days, vendor shall submit drawing to the RCF for approval
 - b) RCF shall approve the same within 7 days from receipt.
 - c) Vendor shall submit back the drawing with RCF comments if any, in 7 days
 - d) Total Delivery period including drawing approval shall be 120 days from the date of issue of pu rchase order through GeM portal.

10) Arbitration Clause:

In the event of any dispute or difference relating to the interpretation and application of the provisions of commercial contract(s) between central public sector enterprises (CPSE'S) / port trusts inter se and also between CPSE'S and government departments/organizations (excluding disputes relating to railw ays, income tax, customs & excise departments), such dispute or difference shall be taken up by eithe r party for its resolution through administrative mechanism for resolution of CPSE'S disputes (AMRCD) as mentioned in DPE OM no. 05/0003/2019-fts-10937 dated 14th December, 2022 and the decision of AMRCD on the said dispute will be binding on both the parties.

This arbitration clause will be in addition to the one, already existing in the GeM GTC.

11) Following Technical and Commercial Pre-qualification Criteria shall be part of the enquiry:

Technical:

The bidder must have supplied equipment for water treatment plants, sewage treatment plants, or effluent treatment plants within the last seven years, ending the last day of the month preceding t he issuance of this enquiry. The bidder shall submit relevant purchase order (PO) copies along with supporting documents, such as delivery challans, commercial invoices, or completion certificates e tc. to validate the execution of the submitted PO.

In case authorized dealer is participating in this enquiry then dealer shall submit valid authorizatio n certificate issued by OEM.

Commercial:

a) Bidder must have Average Annual Turnover of Rs. 9.01 Lakh ending 31 st March of financial year s 2021-2022 ,2022-2023 and 2023-24.

In case, the date of constitution / incorporation of the bidder is less than 3 years old, the average t urnover in respect of the completed financial have I years after the date of constitution shall be tak en into account. In this case, the financial turnover during last financial year/ the average financial turnover during preceding two financial years should be at least Rs.9.01 Lakh. Bidder shall submit audited annual reports certified by Chartered Accountant (CA) or Turnover cert ificates for above financial years. Turnover certificates must have been issued by practicing CA wit h membership number, signed, with seal and acceptable only with UDIN number.

Relaxation in Turnover criteria for eligible MSEs.

For MSEs- Relaxation of 25% in Annual financial turnover shall be applicable.

Start-up bidders must submit the following documents:

a) Start-Up registration certificate issued by the Department of Industrial Policy and Promot ion (DIPP). Year of incorporation of Start-Up shall not be more than ten years from the due date of the tender.

b) Certificate from a Chartered Accountant (CA) with Unique Document Identification Num ber (UDIN), verifying that the Start-Up has not exceeded the financial turnover limit of Rs 1 00 crores (or as revised by the Government of India) in any of the preceding financial years since incorporation.

Start-up bidders has to submit all the requisite documents required for techno-commercial pre-qua lification as specified in the bid/NIT document. However, following relaxations will be given to Start -up bidders:

- a) 25% relaxation in average turnover criteria
- Exemption from Earnest Money Deposit (EMD): Start-up bidders are not required to su bmit EMD.
