## 1. Pre-Qualification Criteria

Bidder should be OEM or their authorized reseller. In case of authorized reseller, they have to submit the authorization certificate.

**NB: For MSE and startup bidders**, past experience is also relaxed. However, bidders have to establish their technical competency by submitting supporting documents towards successful execution of similar work as specified in "Technical Competency Criteria" for **any value**, failure to which the offer will not considered for evaluation.

**2. NOTE: As per para 7.3.5** on (Clarification of Bids/Shortfall Documents) of the Manual for Procurement of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender will be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted.
