- 1. 1. Pre-Qualification Criteria

Bidder should be OEM or their authorized reseller. In case of authorized reseller, they have to sub mit the authorization certificate.

NB: For MSE and startup bidders, past experience is also relaxed. However, bidders have to establish their technical competency by submitting supporting documents towards successful execution of similar w ork as specified in "Technical Competency Criteria" for **any value**, failure to which the offer will not consi dered for evaluation.

- 2. NOTE: As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Pro curement of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During evalu ation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given asking the tenderer to respond by a specifie d date. If the tenderer does not comply or respond by the date, his tender will be liable to be reject ed. Depending on the outcome, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted. No post bid clarification at the initiative of the bidder shall be entertained. - i) The offer is not in the prescribed format or is unsigned or not signed as per the stipulations in the bid document.
- ii) The required EMD has not been provided or exemption from EMD is claimed without acceptable proof of exemption;
- iii) The bidder is not eligible to participate in the bid as per laid down eligibility criteria(example: the tender enquiry condition says that the bidder has to be a registered MSE unit but the tenderer is a, say, a large scale unit);
- iv) The tenderer has quoted for goods manufactured by a different firm without the required authority letter from the proposed manufacturer.
- v) The bid departs from the essential requirements specified in the bidding document (for example, the tenderer has not agreed to give the required performance security); or

- vi) Against a schedule in the list of requirements in the tender enquiry, the tenderer has not quot ed for the entire requirement as specified in that schedule (example: in a schedule, it has been sti pulated that the tenderer will supply the equipment, install and commission it and also train the p urchaser's operators for operating the equipment.
