In case of bunch bids, the category of primary product having highest value should meet this criterion.
2. 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
