| 1. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. Bidders are bound to accept the orders accordingly.

Bidders are bound to accept the orders accordingly.
 - 4. Undertaking that all the certificates / permissions / documents are valid and current as on date a nd have not been withdrawn / cancelled by the issuing authority. The Authority have right to ask f or Original documents if any doubt arises.
- All bidder willing to participate in the Technical Bid online, shall have to send their sample along with man ual to the DFOs office at Bonai physically or by post of checking the efficacy as per the parameters floated. The sample shall reach this office on or before the bid closing date.
- 6. The bidder at their own arrangement shall take back the sample along with the accessories after generatio n of contract. This office shall not take any responsibility for returning of the samples.
 - 7. The warranty of the equipment shall be 1year from the date of acceptance.
- 8. The bidders are requested to submit the details about their product in their letter head, duly signed during submission of technical bid. Basing on their product specification, and other requirement as pre the terms and conditions in the BID technical evaluation shall be made, thereafter acceptance of technical BID, onlin e through GeM.

- 9. All disputes shall be subject to jurisdiction of the Court in Bonai.
- 10. By submitting bid application online every bidder shall be considered to have read the" Mandat ory Terms and Conditions for technical qualification" carefully & given his consent to abide by t he aforementioned terms & conditions. Self signed copy of the "Mandatory Terms and Condition s for technical qualification" is mandatorily required to be uploaded along with Bid application i n GEM Portal.
- 11. The Authority reserves the right to withdraw or relax any of the terms and conditions mentioned ab ove so as to overcome any problem encountered at a larger stage at the sole discretion of the auth ority.
- 12. The prices are inclusive of all duties, handling freight forwarding insurance, etc
- 13. Before delivery of items, mandatory ink signed KYC documents will be provided by this office. Ther eafter for final activation of SIM Cards, DKYC has to be done at BSNL office (location shall be conve yed at the time delivery). Physical visit of the Authorised signatory shall visit the BSNL office.
- 14. Non compliance of any of the Terms & Conditions mentioned in the Bid, the bidder / seller shall be rejected.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
