**Special terms and conditions-Version:1 effective from 27-07-2023 for category Tractors (V1)****1. Special Terms and Conditions for Tractor Procured through GeM**

1. The tractors procured through GeM will now be available through Bid mode only.
2. Buyer's have the option of using PAC "Proprietary Article Certificate" mode of procurement through Bid.
3. Sellers (OEM) and their authorised resellers (channel Partners) those have been authorised by the OEM will only be allowed to participate in the bid.
4. The price quoted in the bid by the OEM, or their Authorised Reseller will include ex-showroom price of the tractor plus delivery charges up-to consignee location excluding Registration and Insurance.
5. The registration and Insurance of the Tractor needs to be done by the buyer at their own cost.
6. The contract can be awarded to OEM or their authorised reseller as per Bid process.
7. The OEM will be responsible for all the warranty obligations, and they may assign their authorised service dealer for getting the job done under their supervision and guidance.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

**2. Scope of Supply**

Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

**3. Service & Support**

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

**4. Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

#### 5. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

#### 6. **Warranty**

Warranty period of the supplied products shall be 5 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

#### 7. **Warranty**

Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.

#### 8. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 5 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

## **Name of the Agri-equipment - Tractor**

1. Under the Scheme, **TALIMPUR PACS BLOCK- GHORASAHAN** will purchase only those agri - implements whose make and model, technical standards and specifications have been certified and approved by relevant agency of Agriculture Ministry / Department of the Government of India or Government of Bihar and whose validity has not expired on the day of the publication of bid. OEMs / Suppliers must be registered / empanelled with the Agriculture Ministry / Department of the Government of India or Government of Bihar and their empanelment validity must be in force on the date of the publication of bid (Relevant documents to prove credentials must be uploaded with bid).

2. Under the scheme PACS intends to buy a Tractor within the range of 45-50 PTO@HP and all such make and models of Tractor specified above within this range would be eligible to participate in the bid process.
3. OEMs / Suppliers must have established and functional service centre in the district **EAST CHAMPARAN** Bihar on the date of the publication of bid (Relevant document must be uploaded with the bid).

Under the Scheme, PACS intend to buy a tractor within a range of 45-50 PTO HP. The engine should be 3 cylinder, Single/Dual Clutch, Transmission-constant Mesh/Suncro Mesh, Maximum 2750 CC engine, torque to be minimum 190 NM, Oil immersed break, Minimum lifting capacity of 2000 Kgs, Manual/Balanced Power steering 2 wheel drive, Gear Box of 8F+2R, Tyre size F6/6.5X16, R13.6/14.9 x 28 2. The supplier should have an authorize service setup within the district.

## **Disclaimer/अस्वीकरण**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
