1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the <u>OM No.1 4 2021 PPD dated 18.05.2023</u> for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 2. 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1.0 ELIGIBILITY CRITERIA:

1.1 Technical eligibility:

1.1.1 The bidder should have experience of having successfully completed/executed s imilar works during the last 7 years ending 31th Dec 2024 as given below:

a) Three similar completed works costing not less than Rs.10.98 lacs excluding GST.

Or

b) Two similar completed works costing not less than Rs.14.64 lacs excluding GST.

Or

c) One similar completed work costing not less than Rs.18.3 lacs excluding GST.

Similar Work: Providing Annual Maintenance Contract (AMC) services / Facilities Mana gement Services (FMS) for IT infrastructure/Setup, such as IT equipment comprising De sktops / Laptops / MFD Printers / Scanners / Servers / Managed Network Switches / Fire wall / UTM / Router.

1.1.2.A The bidder shall have an office in Bangalore. Documentary proof to be sub mitted by Bidder.

1.1.2.B The bidder shall have minimum fifteen (15) qualified technical support engin eers on their company's payroll as on the date of submission of bid having B E / B. Tech / MCA / Diploma in - IT/ Computer Science / Electronics / Instrumen tation. Out of the above supporting engineers, three (3) engineers shall have relevant certifications (CCNA / ITIL / MCSE). Documentary proof to be submitt ed by Bidder.

Note:

- 1) Job Completion Certificates having Work order reference from the end user and Work or der copy shall be enclosed in support of successful and satisfactory completion of the o rders.
- 2) In case a bidder is executing a contract which is still running, the contract value execut ed till one day prior to due date of bid submission is equal to or more than minimum pr escribed value mentioned above such experience will also be taken into consideration provided that the bidder has submitted satisfactory work execution certificate issued b y the end user.

1.2 Financial Eligibility criteria:

The average annual financial turnover of the Bidder during last (3) three consecutive fin ancial years **i.e. for FY 2021-22, 2022-23 and 2023-24** shall be minimum **Rs. 17,2 7,400/-** (Rupees Seventeen Lakhs Twenty-Seven Thousand Four Hundred only).

In order to substantiate the above turnover requirement, bidder shall submit signed cop y of **Audited Annual Financial Reports** (Balance Sheet and Profit & Loss Account stat ement) clearly indicating the details of the Membership No. & Firm No. of the Chartered Accountant & UDIN as per guideline of ICAI.

In case of Companies / Firms which are less than three (3) years old, the average annual turnover of the bidder shall be calculated by considering the turnover as per the audited annual report or CA certificate submitted by the bidder for the available period divided b y three (3). In case of Companies / Firms which are more than three (3) years old, bidde rs are mandatorily required to submit audited reports or CA certificate for all the three (3) consecutive financial years failing which their offer will be liable for rejection.

In case of non-availability of audited annual reports for any genuine reasons, as an alter nate, with reasoned proof, the bidder (sole or consortium) may submit certified annual t urnover from a practicing-chartered accountant, duly notorised, in support of their finan cial credentials, in lieu of annual reports.

Note:

- Relaxation of 15% in prequalification criteria with respect to Prior Turnover to Micro & Small Enterprises and 20% in case of SC/ ST and women Micro & Small Enterprises es shall be applicable.
- 2. Relaxation of 20% in prequalification criteria with respect to Prior Turnover to Startu ps shall be applicable.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the

case may be.

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
